### **STATEMENT OF WAIVER**

The participant and/or spectator hereby agrees to the following conditions in respect of participating in the PIF Regatta in QLD for the benefit of the Property Industry Foundation (PIF):

1. I hereby acknowledge and accept that my participation in the PIF Regatta can be dangerous and includes activities which, by their nature are inherently risky and may result in my injury, death, or loss or damage to my person or property. I have voluntarily read and understood this warning and accept and assume the inherent risks in the PIF Regatta..
2. I agree that any warranty implied by law into this agreement is expressly excluded to the extent permitted by law, including but not limited to any warranty implied by virtue of the Australian Consumer Law set out in Schedule 2 of the Competition and Consumer Act including that the services provided by PIF are provided with due care and skill (and any similar statutory warranties).
3. I agree that PIF cannot be held liable for any unforeseen mechanical, gear or rigging issues that may occur to the boats.
4. In consideration of PIF accepting my application for entry to the PIF Regatta I:
  - a.
